

Report of payments to government agencies 2024

This report has been prepared in accordance with the Swedish Law (2015:812) on reporting of payments to government agencies and refers to the financial year 2024. Boliden AB (publ) is presenting this report because the Boliden Group includes companies that conduct extractive industry operations.
